Booking Terms & Conditions

1. On arrival the Group leader MUST report to the Campdowne Reception before going to a camping area.
2. In the event of a booking being cancelled at less than 60 days notice, or in the event of a non arrival, the right is reserved to charge the full price for the facilities booked. A notification of cancellation MUST be made in writing.

ALL DEPOSITS ARE NON REFUNDABLE AND NON TRANSFERABLE. A DEPOSIT IS REQUIRED WITH EVERY BOOKING MADE.

3. Campdowne will hold your booking on a provisional basis for **21 days only** from date of booking. If a deposit has not been received within this period we may cancel the provisional booking.
4. Campdowne expects the balance of all monies owed to be paid as soon as your participation numbers are confirmed and no later than **31st March 2008**.
5. All cheques must be made payable to **The Scout Association**.
6. We reserve the right to charge groups who damage equipment or buildings, or who fail to leave their site in a reasonable condition.
7. Whilst we will always endeavour to allocate groups to the subcamp that has been requested, if conditions so indicate, we reserve the right to move groups to other subcamp sites without prior consent. We also reserve the right to change activity bookings.
8. Responsibility for the supervision and welfare of groups remains with the 'responsible adult' (contingent leader) notified on the booking form overleaf
9. Dogs (and other pets) are not allowed at Campdowne unless specific authority has been obtained from the Admin Team.
10. Please seek permission before driving to your subcamp; to avoid incurring a fee should we have to recover your vehicle from the site.
11. The speed limit is 5 miles per hour at Campdowne.
